This letter memorializes the notification made before June 18, 2025, by the Committee for the Assessment of Foreign Participation in the United States Telecommunications Services Sector (“Committee”) to Commission staff that, based on available information, the Committee does not believe a referral of this application under Section 5 of Executive Order (“E.O.” 13913) is necessary.

In making this determination, the Committee considered engagement with the Applicant, engagement with Commission staff, the application,<sup>1</sup> standard questions responses, potential law enforcement and national security risks related to this application, information from the Committee’s review of the Applicant’s prior applications,<sup>2</sup> and the Committee’s ongoing monitoring of the Applicant’s compliance with their June 29, 2020 mitigation agreement.<sup>3</sup>
